# A MESSAGE FROM THE CEO AND BOARD CHAIR

Thank you for your ongoing support of Model Cities and its mission to provide social and economic prosperity by providing access to opportunities that stabilize and develop families and communities. By remaining focused on our mission, Model Cities reached some incredible milestones in 2018, and we are moving boldly into 2019, with the continuous goal of improving the social and economic outcomes of individuals and families in our community.

Our human impact cannot be overstated. Real change is evidenced everyday as a result of our work in the community. In 2018, we completed a \$2.1 million dollar project which included rehabilitation of five supportive housing apartment buildings. This rehabilitation project will help preserve affordable housing units for families with extremely low incomes, people with disabling conditions, and those who've experienced homelessness, for years to come. We also increased our capacity to carry out financial education services through the Fiscally Fit Initiative. This is a product of the Camphor Fiscally Fit Center's (CFFC) comprehensive financial empowerment literacy program for individuals and families. In January 2018, the CFFC transitioned to Model Cities, where we have continued to provide financial education and oneon-one coaching services to nearly 100 small business owners, young adults and households with low to moderate incomes.

For over 50 years, Model Cities has been committed to making its surrounding neighborhoods a 'model' environment. Because you have believed in our mission over these many years, families have safe and affordable housing; at-risk youth are receiving mentoring services and support; small business owners are creating better financial pathways to entrepreneurship; and families with low incomes are becoming first-time homebuyers. On behalf of everyone here at Model Cities, we would like to thank you, our community members, supporters, partners and funders for your continuous support.



### **CHILDREN'S MENTAL HEALTH (CMH):**

**100% of children** who received Targeted Case Management Services were able to avoid CMH initiated residential placements as a result of Model Cities' services to stabilize families.



### **HOLIDAY GIVING:**

**125 parents and children** from our supportive housing and Children's Mental Health programs received holiday gifts including clothing, shoes, and toys from our holiday sponsorship volunteers.



### **ART & WELLNESS:**

74 community members attended curated art & wellness events such as the *Music Jams* in the Pocket Park and participated in other art and cultural events in The Reading Room at BROWNstone.



### YOUTH EMPLOYMENT:

74 young people participated in our Community Coaching Program and acquired the skills necessary to enter the working world. Of those who participated, 80% completed the training in full; with 60% obtaining employment within the year.



### **INTENSIVE CASE MANAGEMENT:**

**93% of families** working with Model Cities participated in community group activities, volunteer opportunities and employment education.



### **FISCALLY FIT:**

**93 people** participated in our new Fiscally Fit program and gained the financial knowledge and skills needed to manage their personal and household budgets. Participants received information on topics ranging from credit card debt management to budgeting for small business owners and individual households.



### **HOMEBUYER COUNSELING SERVICES:**

**67 households** received FREE one-on-one pre-purchase counseling services to assist with overcoming homeownership barriers.



### **HOMEBUYER EDUCATION:**

136 households participated in HomeStretch, a course designed to help participants understand the home buying process. Upon completion, participants are eligible to receive down payment assistance toward the purchase of a home.



### SUPPORTIVE HOUSING:

**104 adults and children** were served through our Sankofa and Families First Supportive Housing programs.



#### **FAMILY COACHING:**

Through the Family Coaching program, Model Cities provided **over 400 hours** of wrap around services to families with children ages 5-13 years old who attend Saint Paul City School.

In partnership with the Saint Paul Promise Neighborhood, the Family Coaching program is designed to support families with improving educational outcomes for their children.


# Model Cities Supportive Housing Rehab Project

In 2018, Model Cities implemented a \$2.1 million Supportive Housing Rehab project. This project, funded by MHFA, the Federal Home Loan Bank, and private donors completed the much-needed enhancements to all five supportive housing buildings. Improvements included upgrades for energy efficiency along with new boilers, new roofing, as well as health and safety improvements such as smoke detectors and emergency exit signs and heavy duty window screens. In addition, ceramic tile entryways, and new flooring was also added to the apartments to create a better, cleaner living space.

The highlight of this project was the installation of new playground equipment at the two Sankofa program buildings as well as 914 Thomas. A new community room at 625 Chatsworth and new computer equipment in each of the apartment buildings were also important components of the update. These additions have already proved extremely popular with the parents and children residing there.

In September, Model Cities celebrated the completion of the Supportive Housing Rehab project and the opening of the Agape Community Room at the Sankofa buildings with an open house event that included members of the community, local politicians, funders, contractors, Model Cities staff, and residents. The open house marked the end of the rehab project and honored all who were involved in its successful completion.

With this rehab project now complete, Model Cities will continue to provide safe, well managed, affordable housing units for today's residents and for future generations.






# The BROWNstone Development


Model Cities is the owner of the four-story BROWNstone mixed-use development, located at the Victoria Street Light Rail Transit Station on the Green Line in St. Paul. This development includes 35 units of affordable, workforce housing; approximately 20,000 square feet of retail, office, and community space; and nearly 7,000 square feet of outdoor space reserved as a pocket park which includes public art by the noted local artist Marjorie Pitz.

The 20,000 square feet of commercial space includes Model Cities' offices as well as five retail suites located along University Avenue. Privilege Groomers opened in December of 2017 and steadily grew its business throughout 2018. Soon after, two new other leases were signed with small business owners in 2018. Midway Grocery and Deli, a convenience store, Halal meat market/deli located adjacent to the BROWNstone pocket park promises to serve not only the BROWNstone but the Frogtown community area as well. Phenom Apparel, located just down from the barber shop, offers Nike and athletic wear and has already developed a dedicated clientele.

All three businesses are owned by people of color who live in the community. More than a dozen jobs have been created with these businesses, with the promise of more hires yet to come as they become more established. Model Cities continues to work diligently to fill the other two suites and hopes to have signed leases sometime in mid-2019. In this way, Model Cities has created the social and economic prosperity and opportunities to stabilize the community as intended.
